IOWA STATEWIDE POISON CONTROL CENTER (ISPCC) PROVIDES IOWA'S 3.0 MILLION RESIDENTS 24-HOUR TOLL-FREE TELEPHONE ACCESS TO EMERGENCY POISON INFORMATION AND TREATMENT ADVICE FROM SPECIALLY TRAINED NURSES, PHARMACISTS AND PHYSICIAN TOXICOLOGISTS. THE ISPCC CAN ASSIST PEOPLE OF ALL LANGUAGES AND THE HEARING IMPAIRED. DURING THE FISCAL YEAR 2017-18, THE ISPCC RESPONDED TO 30,545 CALLS, INCLUDING 25,737 HUMAN EXPOSURES TO POISONOUS SUBSTANCES AND 4,808 CALLS FOR REQUESTS INVOLVING DRUG IDENTIFICATION, ANIMAL POISONINGS, OR OTHER INFORMATION CALLS.
